## Objective

ICC's Annual Miami Conference is a key forum for understanding international arbitration in Latin America. Our **Sunday Conference "ICC Arbitration Special: The World Cup and Olympics coming to Latin America"** will adopt a sporting theme and tackle the different issues related to the organization of worldwide sports events. Panelists will consider the place of arbitration in resolving such disputes and discuss practices and procedure applied in this specialized field.
