

## Nigel van Zyl Named Most Influential Lawyer by Financial News for Second Year

In 2022, Nigel advised <u>One Peak</u> on the formation of its latest fund, One Peak Growth III, which closed at its hard cap of \$1 billion.

Nigel is counsel to some of Europe's largest private equity investors and best-known for his work on buyout fund formation. He has been a go-to adviser for Hg Capital on all its buyout funds for more than two decades. He recently advised on their two major fundraisings; Saturn 3, which raised \$11 billion, reaching its hard cap which makes it the largest European buyout fund to close in 2022 and Genesis 10, which reached its hard cap of \$7.4 (Eur 6.75) billion.
