The vehicle will allow Coller funds to invest in private market secondaries. Coller also partnered with Barings Portfolio Finance (“Barings”) for the vehicle. Barings acted as the lead lender for the transaction with Coller and Ares providing the credit enhancement.

The vehicle is the largest-ever structured funding vehicle of its kind in the secondary market to invest in both private equity and private credit secondaries.
