SPV Formed to Acquire Life Insurance-Linked Securities Portfolio

NEW YORK, October 7, 2025 – Proskauer advised Hudson Structured Capital Management – conducting its re/insurance business as HSCM Bermuda (“HSCM”) – on the closing of a new secondaries acquisition vehicle, HS Sawmill LP (“HS Sawmill” or the “SPV”), with \$110 million in capital commitments from institutional investors. The SPV was formed to acquire a seasoned portfolio of life insurance-linked securities with additional follow-on reserves.
