His achievements have earned recognition through numerous accolades, including being named Antitrust Litigator of the Year by *Benchmark Litigation* in 2025.

A Fellow of The American College of Trial Lawyers, Bart has served as lead counsel for numerous Fortune 500 companies in their most challenging and high-profile matters. He is frequently brought in just months or even weeks before trial to secure a win and has a distinguished track record of success. In 2023, Bart obtained a complete defense verdict on behalf of Gilead Sciences in a \$3.6 billion antitrust case alleging that Gilead struck an anticompetitive "pay-for-delay" settlement agreement with a leading generic drug manufacturer to resolve a patent invalidity lawsuit for the purpose of delaying the generic's entry into the relevant market for two of Gilead's highly successful HIV medications.
