This £33 million acquisition includes the global brand and related IP, the UK brewing operations and eleven brewpubs in the UK and Ireland.

This acquisition presents a significant opportunity for Tilray’s growth in the UK and previously untapped international markets. Tilray is separately negotiating to acquire certain BrewDog assets in the United States and Australia.
