

Proskauer Advises Columbia Capital on Agreement to be Acquired by Digital Realty

NEW YORK, June 30, 2026 - Proskauer advised investment firm Columbia Capital (“Columbia”) on its agreement to be acquired by Digital Realty (NYSE: DLR), the world’s largest cloud- and carrier-neutral data center platform, for approximately \$485 million and a potential ~\$275 million earnout by year-end 2027. The transaction is expected to close in the second half of 2026 and remains subject to customary closing conditions and regulatory approvals.
