For example, Adam helped guide Major League Baseball (MLB) through its most recent work stoppage with players, represented MLB in grievance arbitrations challenging player discipline for violations of the league’s domestic violence and drug policies, successfully defended MLB against discrimination claims brought by Angel Hernandez, and defended MLB and its member Clubs in class and collective actions involving pay practices of minor league players and claims of age discrimination by scouts. In addition, Adam has handled several litigations and arbitrations for the National Hockey League and National Football League, and has advised college athletic conferences and universities across the broad spectrum of labor and

employment laws.

Adam also leads the Firm's MLB Salary Arbitration practice, and is one of the most sought-after practitioners to represent Clubs during contract negotiations and at arbitration hearings against some of the game's most prominent players.

### Representative Matters

- ? Major League Baseball in the labor dispute with the Major League Baseball Players Association and the negotiation of a new collective bargaining agreement.
- ? Icahn School of Medicine at Mount Sinai in connection with a response to an organizing drive and petition for election seeking to unionize graduate students.
- ? Montefiore Medical Center and the League of Voluntary Hospitals and Homes in connection with the New York State Nurses Association strike involving more than 7,000 nurses.
- ? *Benedict et. al v. Manfred et. al* in a putative class and collective action against MLB and its member Clubs brought on behalf of baseball scouts alleging claims of age discrimination.

?? *Johnson v. NCAA* (3d Cir.) authored an amicus brief on behalf of the American Council on Education (ACE) in support of the NCAA's position that college athletes should not be deemed to be employees covered by the Fair Labor Standards Act.

? *Angel Hernandez v. Major League Baseball* (2d Cir. and S.D.N.Y.) in successfully defending against race and national origin discrimination claims brought by a current Major League umpire.

? *Major League Baseball* in a grievance arbitration challenging player discipline for domestic violence and sexual assault, which resulted in the longest suspension for a player in MLB history.

? *Boogaard et al. v. National Hockey League* (7th Cir. and N.D.II.) in the complete dismissal of wrongful death claims brought by the estate of Derek Boogaard, a former player for the New York Rangers and Minnesota Wild.

? *In re National Hockey League Players' Concussion Injury Litigation* (D. Minn.), a multidistrict litigation brought by retired NHL players who allege to suffer from the effects of concussions.

? *Alex Rodriguez v. Major League Baseball et al.* in playing a leading role on the trial team that defended the grievance arbitration and related litigation challenging the suspension of then-New York Yankees third baseman Alex Rodriguez.

? *Senne et al. v. Office of the Commissioner of Baseball et al.* (N.D.Cal.) in a class and collective action lawsuit brought on behalf of current and former minor league players who alleged minimum wage and overtime violations.

? *Wyckoff et al. v. Office of the Commissioner of Baseball et al.* (S.D.N.Y.) in obtaining a complete dismissal of the class and collective action complaint brought on behalf of baseball scouts.

? Salary arbitration proceedings against players such as Max Fried, Kyle Tucker, Austin Riley, Josh Donaldson, Marcus Stroman, Dansby Swanson, and numerous other players.
