Matters

Monopolization Cases

- *Castro v. Sanofi Pasteur Inc.* Lead counsel for Sanofi Pasteur in defense of a nationwide class action alleging that Sanofi monopolized the alleged market for meningitis vaccines in the United States through bundling and other exclusionary conduct.
- *TrueEx LLC v. MarkitServ Ltd.* Lead counsel for MarkitServ in defense of an antitrust claim, seeking to impose a duty to deal with a competitor in the alleged market for processing Interest Rate Swaps.
- *ChampionsWorld v. Major League Soccer.* Counsel for Major League Soccer in its successful defense of a claim that it foreclosed competition in the alleged market for the promotion of international exhibition soccer matches.
