Representative Matters

- Represented the trustees of several Bermuda trusts worth in excess of US\$20 billion in multiple cross-border proceedings attacking those trusts, including the largest claim by value ever to come before the Bermuda Supreme Court.
- Acted in a complex competition law dispute before the Competition Appeals Tribunal in a matter valued at over £9 billion.
- Acted for Vodafone International Holdings B.V. in its victory against the Republic of India under the Netherlands-India bilateral investment treaty in relation to India's attempt to impose a US\$5.5 billion liability onto Vodafone and its Indian subsidiary through retroactive withholding taxes, interest and penalties.
