**Kate has represented her clients in several significant matters in the trial and appellate courts, as well as in arbitration, including, among many others:**

- Defense of an aerospace research and development company in a putative nationwide collective and class action for age discrimination, arising out of a widespread reduction in force. Defeated class claims in both federal and state court and obtained summary judgment in remaining five single plaintiff cases.
- Defense of a national retail merchandiser in a putative class action alleging various wage and hour violations (off the clock, meal and rest break, expense reimbursement). Defeated class certification on all but one claim which was resolved for a small fraction of Plaintiff's original demand.
- Defense of a national restaurant supply wholesaler in putative collective and class action alleging misclassification of managers. Successfully compelled entire action to arbitration on an individual basis.
- Lead counsel for a prominent Southern California medical group in arbitration brought by hospital department Chair for breach of contract, fraud and defamation. Prevailed on all claims.
- Lead counsel for television network and production company in pregnancy discrimination claim by a former model/actress. Prevailed on a motion for new trial, vacating verdict. In a companion case by a second model/actress alleging pregnancy discrimination, obtained summary judgment, which was affirmed on appeal.
- Lead counsel in arbitration on behalf of producer of longest-running, nationally broadcast television game show. Obtained arbitration award in action for retaliatory failure to hire and age and gender discrimination. Arbitration award was affirmed in full by California Court of Appeal.
- Lead counsel in arbitration on behalf of the nation's largest publicly traded Hispanic-controlled media and entertainment company to enforce exclusivity provisions of employment agreement for morning drive time star disc jockey.
