In 2023, he was a lead member of the trial team that secured a landmark defense victory for Sanderson Farms, defeating \$7 billion in damages claims after a six-week jury trial in the U.S. District Court for the Northern District of Illinois.

His accomplishments have earned him recognition as one of the leading young antitrust litigators in the country. Most recently, Stephen was selected as a Rising Star by *Law360*, named to *Benchmark Litigation’s* “40 & Under List” and recognized in *Best Lawyers: Ones to Watch in America* for 2026.

In addition to his antitrust work, Stephen counsels clients on consumer protection and marketing practices, including false advertising disputes. He has handled precedent-setting matters before the FTC and state attorneys general, giving him

- Defending a leading revenue-based financing company in an action brought by the Federal Trade Commission alleging violations of the FTC Act, and in related investigations by state attorneys general
