Meridian Heights Class Action Housing Litigation

In 2021, a Proskauer team cocounseled with the Washington Lawyers Committee for Civil Rights & Urban Affairs to file a class action lawsuit challenging horrific housing conditions and discrimination at the Meridian Heights housing property. Since then, Proskauer attorneys and staff have devoted substantial time to the matter, engaging in extensive discovery, motion practice, client management, and negotiation. This fall, the parties reached an agreement in principle to settle all claims brought in the litigation and provide a variety of relief to the class members. The Court preliminarily approved the settlement late last year, with a final approval hearing set for March.

Supreme Court Victory for Department of Defense Employee

This past May, a Proskauer team succeeded in obtaining a 9-0 victory at the Supreme Court on behalf of Stuart Harrow, a former Department of Defense employee. Harrow had appealed to the Merits Systems Protection Board after a furlough in 2013, arguing he was entitled to lost pay. He lost and appealed to the Court of Appeals for the Federal Circuit, but the Court dismissed his appeal as untimely, finding the statutory filing deadline to be jurisdictional and not able to be extended. The Supreme Court unanimously ruled that the deadline imposed on Mr. Harrow was not jurisdictional because Congress had not spoken with a clear statement

to overcome the presumption that time bars are non-jurisdictional and open to equitable tolling. The Court vacated the judgment and remanded the case back to the Federal Circuit, where Mr. Harrow can again pursue his claim

Delaware Voting Rights Litigation

In late 2023, a Proskauer team co-counseled with the ACLU Voting Rights Project, the ACLU of Delaware, and Shaw Keller LLP to file a federal lawsuit in Delaware seeking a preliminary injunction requiring the state to make voting available in iails and prisons in Delaware in the 2024 election. After suit was brought, the ACLU of Delaware met with the Delaware Departments of Corrections and Flections and was informed that the departments were working on coordinating an in-person DOE presence in at least some DOC facilities to help facilitate absentee voting, in addition to several other positive steps concerning rights restoration and administration of elections for incarcerated voters.

Securing Discharge Upgrade on Behalf of Veteran Client

Since 2018, Proskauer has acted as pro bono legal counsel for a veteran who experienced racial discrimination during his service in the U.S. Marine Corps. The client was stationed at Camp Pendleton in the mid-1970s. At that time, members of the Ku Klux Klan ("KKK") served openly and actively at Camp Pendleton. The client faced a pattern of severe harassment, beatings and threats of sexual harm and death by his immediate superior and others on his base, many of whom were active members of the KKK. In fear for his life and safety, he eventually went absent without leave, causing him to be unfavorably discharged from service. After years of work, a Proskauer team successfully obtained a discharge status upgrade for the client this past June. Following this good news, the client wrote: "It is evidently a labor of love to bring justice to those who have lost all hope of being heard. In my case, you gave me something I lost at the age of 22 years old . . . which, was my good name."

Helping Children Access Immigration Status in the UK
